



## **Use of Photographs from the Art Apprentice Online Photo Gallery**

The Non-Exclusive Downloading Member (Subscribing Member to the AAO E- Magazine) acknowledges and agrees that this Agreement does not effectuate any sale of the photographic Work. Except for the rights specifically sublicensed under this Agreement, the Non-Exclusive Downloading Member shall not have any right, title or interest in or to, and in any event shall have no ownership of, the Work, including any copyright and other intellectual property rights. The copyright is held by Art Apprentice Online and the individual creator of the photograph.

### **Standard License:**

Subject to the terms and conditions of this Agreement, The Art Apprentice Online hereby grants to the Non-Exclusive Downloading Member (Subscribing Member to the AAO E-Magazine) a non-exclusive, perpetual, worldwide, non-transferable sublicense to use the images as artistic reference material solely for personal purposes.

The Non-Exclusive Downloading Member shall have no right to grant further sublicenses to a third party.

### **Extended License:**

In order to obtain the right to sell or distribute for sale the derivative Work if the exact copy of the image from the AAO photo gallery is incorporated or reproduced into any art work in any media, the Non-Exclusive Downloading Member shall pay to Art Apprentice Online a sublicense fee of \$25. Per image, for this **Non-Exclusive Extended License – Payment can be made in our shopping cart.**

For clarification purposes but subject to the foregoing restrictions, it is intended that this sublicense shall permit the member to reproduce, distribute and /or display the derivative Work *as a hand painted design*. Not to be used for resale and use, reproduce, distribute or display the Work (photographs or art work) in connection with any goods or services intended for resale or distribution, including, without limitation, mugs, t-shirts, posters, greeting cards, posters or other merchandise, and any of the foregoing in "print on demand" or tangible or electronic formats, as applicable; use, reproduce, distribute or display the Art Apprentice Online photographs or Art Work in connection with a PR campaign aimed at the promotion of goods or services to the medias.

### **Restrictions**

Notwithstanding anything to the contrary contained in this Agreement, and without limitation to any aforementioned restrictions, the Non-Exclusive Downloading Member acknowledges, agrees and warrants that he or she shall not:

Sublicense, sell, assign, convey or transfer any of its rights under this agreement. Sell, license or distribute the Work or any modified Work as stand-alone files or as part of an online database or any other database, or any derivative product containing the Work in such way that would allow a third party to download, extract or access the Image as a stand-alone file.

Share the Work with any other person or entity except as expressly permitted under this Agreement.

**Requirements:** All art work created under the terms of the Extended License must clearly note the original source of the reference material as originating from the Art Apprentice Online Photo Gallery.

**Clarification:** Standard copyright applies to *all the photographs* of the Art Apprentice Online Photo Gallery. Any use of, reproduction of, portions of, in part or in whole *require the purchase of the AAO Artist's Extended License.*

Purchasers of the AAO Artist's Extended License will notify the Art Apprentice Online of the specific image used – i.e. – number of the image. A digital text document (Extended License) will be emailed to the subscribing Member. This will be the documentation needed for the Non-Exclusive Downloading Member's records.

**To obtain an Extended License:**

1. Must be a subscribing member of the AAO E- Magazine.
2. Login to the Art Apprentice Online Photo Gallery.
3. Select the image you want to paint.
4. Purchase the *Extended License* at the following link:
